### Key Features

- ✓ **Merge From Major Real Estate Packages** ADLForms enables other industry software programs to merge data into most ADL forms. This feature provides a faster and more accurate method of completing forms, directly from the data already stored in your database, preventing costly errors associated with double handling ([click here](#) for more information).
- ✓ **Save Completed Forms Where You Choose** You can save your completed forms to any location (eg. the property folder the form relates to), including your network server for easy backup and retrieval.
- ✓ **Unlimited Templates** You may setup unlimited templates per form. Templates are a handy way to automatically populate fields within a form, thereby reducing the amount of typing required. Templates can be used in conjunction with the Third-Party Merge Facility.
- ✓ **Expandable Condition Reports** Entry, Exit & Routine Condition Reports will allow up to 3,000 characters for each item comment. To enable this feature ADLForms automatically expands the report when printing so that all comments are printed in full.
